## Terms & Conditions

1. The Rookie Day 2019 fee is \$125. This is a non-refundable fee. At the end of the day on July 20<sup>th</sup>, families will receive a voucher for the sum of \$125 that can be applied as a tuition discount for the summer of 2020. The Rookie Day fee includes a tour of Camp Eagle Hill (hereby referred to as Camp), a Parent Q&A, a multi-activity schedule for children enrolled in this day (hereby referred to as Rookies), a Camp T-shirt, a bunk photo, and a full buffet lunch.
2. Camp is not responsible for campers' equipment or personal belongings while at Camp.
3. A signature on this enrollment form grants to Camp the permission to use any photograph, video or audio footage, likeness, or thoughts expressed during a camp sponsored interview in which the enrolled Rookie may appear, or take part in (regarding an interview). This permission shall extend to the Camp while the enrolled Rookie is actually at camp, or while the camper is participating in any camp sponsored activity (i.e. a camp reunion) during the full year preceding or following the camper's actual participation in the camp program at the camp facility. All photographs, video or audio footage, likeness, or thoughts expressed during an interview, may be used on an Internet Website, for advertising, or other commercial purposes.
4. The parent or legal guardian and enrolled Rookie(s) agree to abide by all rules and regulations set by the Camp for the health, safety, and welfare of the children and staff at camp. Such rules and regulations may be provided in publications to camp families or provided to the campers while at camp itself.
5. Any information about your child regarding Allergies, Dietary Needs, Medications, Medical Issues, or any additional information you deem necessary must be noted on Page 1 of this enrollment form and must be discussed with Camp prior to your arrival for Rookie Day 2019.
6. It is understood that Rookie Day 2019 is designed to be a "taste" of the Camp Eagle Hill program and overall camper experience. As such, it may not be possible for a child to experience all activities offered by Camp Eagle Hill. Any thoughts that would keep your child from participating in any particular activity, due to physical limitations or otherwise, must be noted on Page 1 of this enrollment form and discussed with the Directorship of Camp Eagle Hill prior to your arrival for Rookie Day 2019.
7. Permission is given to the Camp Director or medical personnel selected by the Camp Director, to have the child/children enrolled on this form, seen by a physician in a physician's office off the grounds of Camp, or at the hospital, when deemed necessary. Permission is further given to a physician selected by the Camp Director in the event of surgical or medical emergency, to provide hospitalization, secure proper treatment for, and order injections, anesthesia, or surgery for the enrolled child/children named on this enrollment form.
8. It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, can only be brought in a court of competent jurisdiction located in Columbia County, NY and shall be construed in accordance with the laws of New York State.
